Ibrahim Elbadawi

Mr. Ibrahim Elbadawi is the Managing Director of the Economic Research Forum and a Professor Emeritus at the University of Khartoum. Between September 2019 and July 2020, he was the Minister of Finance and Economic Planning in Sudan. Prior to that, he was Director at the Economic Policy and Research Center, lead economist at the Development Research Group of the World Bank, and Professor of Economics at the University of Gezira in Sudan. He has edited books and special editions of referred journals and published over 90 articles on macroeconomics, growth and development policy, democratic transitions, and the economics of civil wars and post-conflict transitions.

Nivine El Kabbag

H.E. Ms. Nivine El-Kabbag has over 25 years of experience in the field of international cooperation, strategic management, institutional development, and social policies. She is the current Deputy of the Minister of Social Solidarity of Egypt. Prior to that, she worked with UNICEF for over 10 years. She is also the founder and former chairperson of the first Egyptian Research and Evaluation Network. She holds a Master's in International Political Economy and International Relations.

Rana Jawad

Ms. Rana Jawad is an associate professor in social policy at the University of Bath in the United Kingdom, and founder of the MENA Social Policy Network. Her academic career has been devoted to the study of social policy and social

She is also internationally known for her work on promoting the use of non-fresh water in agriculture and the empowerment of women in science. She holds a PhD in Genetics from the University of Cordoba.

Ms. Linda Shaker Berbari is an expert in public health and community nutrition, with over 18 years of experience in Lebanon and the Middle East. She earned her PhD from the University of Dundee, with a focus on public health nutrition policy and on infant and young child feeding in emergencies. She has worked with international organizations, United Nations agencies, and academic institutions through her engagement in community nutrition

Mr. Abuthnain is also a member of the boards of directors of multiple investment companies in Saudi Arabia.

Fayez Ali Al-Mutairi
